

**STATEMENT****Estimated time of completion for the e-learning modules on ETPLAS**


To support the recognition of the e-learning modules available on the ETPLAS website as Continuing Professional Development (CPD), a working group within the Spanish National Committee for the Protection of Animals used for Scientific Purposes (CEPAFIC), in collaboration with the Spanish National Research Council (CSIC), estimated the median time required to complete modules EU-10, EU-11, EU-12, EU-25, and EU-60.

For the additional 17 modules developed under the LAS-Learning project, time estimates were provided by module testers based on their completion times.

This document lists the estimated times of completion and may be attached to ETPLAS module certificates to support CPD recognition requests.
